The first quarter for the year is finished and we are in good fiscal shape and all categories are within their expected budget. There is a need to re-align the team budget allocations for the Sexton/Audio position because of the change in the structure of the two positions. Peter and Khleber will look into it and update the budget to reflect the correct allocations.

The Fiscal Team's Travel group's request to serve alcohol: The travel group requested to be able to provide alcohol in the form of beer and wine from Sicily for the two informational dinners they are doing for the Sicily trip in 2017. The motion to allow the travel group to provide alcohol for the Sicily dinners in August and September was approved. Dave L will contact the Committee with the approval.

Support for social activities without charge: A proposal was presented to the board to support the Social Activities Team to provide free events for the whole congregation. The discussion centered around providing a wider variety of events for all ages and funding through increased stewardship. A vote of confidence was passed for the social activities committee to provide more variety of events with no charge. Linda U will contact the Social Activities Committee and let them know they have the support of the Board Of Trustees to move forward.

We ended the first Quarter of the church year and are in good fiscal shape. We ended June with \$120,343 in Operating Funds.

We took in \$21,073 and spent \$18,887 in operating funds during June. All of the categories are within their expected budget limits.

I made a mistake when paying our denominational dues paying the amount for next Fiscal Year of \$18,655. Rather than get some money back I took a credit of \$3.750 towards next years pledge.

I also moved family promise money to a restricted account so that I can keep track of it.
