Treasurer's Report

Our operating funds currently stand at \$89,444. Total assets are \$298,602. Ten thousand (\$10,000) will be put into capital reserves. Two hundred fifty thousand dollars (\$250,000) of the Endowment, currently in Vanguard funds, will be moved to the Gulf Coast Community Foundation where the fee will be 0.5%. Restricted funds will be left in Vanguard. Ten thousand dollars (\$10,000) from the Futures Fund will be moved into the Endowment.

John Spitzer and Mark Murray will co-chair the Stewardship Committee when Dan

Hadley leaves in December. The Pledge Campaign will be a one-day event in 2019. Treasurer's report is appended.
