June 7, 2020: Video Online Service: The Myth of Original Sin

Rev. Dennis McCarty will explain "The Myth of Original Sin." Like hell-fire, Original Sin is a core Christian doctrine, particularly among fundamentalist expressions. But—surprise!—it was not part of Jesus of Nazareth's message at all, nor was it important among Christians until hundreds of years after Jesus died. Rev. Dennis will sort out this fascinating piece of religious history.

June 14, 2020: Video Online Service: A Religious Look at Dracula

Rev. Dennis McCarty will take "A Religious Look at Dracula." Prince Vladislas Dracula was a real person. Less than a hundred years after his death, Transylvania—his supposed home—anointed history's first and only Unitarian King, John Sigismund. Bram Stoker's vampire Dracula and the historic Dracula were two very different characters, though. We can learn a lot about Unitarianism—and ourselves—by comparing the surprising differences.

June 21, 2020: Video Online Service: A Brief Biography of Satan

Rev. Dennis McCarty will outline "A Brief History of Satan." As with other supposedly Scriptural ideas, Satan—a.k.a. the Devil—evolved and changed over the centuries. Culture and psychology influenced this evolution, so that the "Devil" that Jerry Falwell, Jr. warns us about has a lot more to do with subconscious European longings than anything the earliest Hebrew scribes wrote down. Knowledge about what's actually in the Bible—and what's not—can help us reclaim this fascinating and wonderful book from fundamentalists who try to use it as a cudgel.

services. She wrote, "Based on advice from experts. . . [we] recommend that congregations begin planning for virtual operations for the next year (through May 2021.)"

She then added, "Take a moment to breathe. I know this is significant," and detailed how the UUA is expanding resources for congregations to increase virtual (online) relationships even in the event of a protracted shutdown.

Reactions were predictable. Some people, (including some ministers I know) sputtered "How dare the UUA tell us we can't re-open as soon as we think it's safe?"

Well—that's not what the "Updated Guidance" said. For one thing, the UUA can't "tell" a Congregation to do much of anything. Congregational polity doesn't work that way, as I explained in my first sermon here. We run our own show and make our own decisions.

But in advising us to "begin planning," Susan was warning that this pandemic is likely to be a long, hard slog. Be ready. After all, it's much easier to pivot back to "traditional" church, if circumstances change sooner than planned, than it is to go forward with a full-service "virtual" church without careful planning, ramping up our online resources.

I've been following this pandemic closely, and also your response as a congregation. I think your Board of Trustees, Staff, and Lay Leaders are responding beautifully. (In fact, some folks are so forward-thinking, I'm having a hard time keeping up!)

Salli, our Office Manager, has recommended weekly "virtual office hours," beginning in June, so people can talk to her via Zoom if they need to. I will almost certainly do the same—though I'm still figuring out what would be the best afternoon. Keep your eye on our "Happenings" e-mail for more on that.

Back in the middle ages, particularly in times of war, castles laid in supplies so that they could withstand a long siege. This COVID-19 pandemic is the moral equivalent of a war. If the siege doesn't last as long as planned, we can always eat the laid-away beans and rice in a big feast when it's over. (Or to put things more plainly—as even the loudest critics proclaim—"Our online services have been very successful. We'll continue to provide them after the pandemic passes.")

I'll be leaving in a few weeks. I have two aspirations: first that none of our beloved members comes down with COVID-19 on my watch. (So far, so good on that one.) Second, that I hand off to Rev. Van Zandt a congregation ready to withstand even a long pandemic siege. Thanks to level-headed lay leaders and dedicated staff, I look forward to being ready on that one, as well.

UUCOV COVID-19 Task Force

Our group continues to meet on a monthly basis with a focus on reviewing current information received from UUA, Florida Department of Health, the CDC and various other sources. Our guiding principle continues to be how can we best stay informed and ensure that our UUCOV congregation remain connected while remaining cautious and diligent in maintaining the safety of our staff, our congregation, and our community. Our recommendation to the Board has been to continue with video Sunday services, ZOOM meetings, and the closure of our campus buildings until further notice. We believe following the guidance of science along with our UU values is the responsible way to operate.

An Opportunity to Support our Mission

Our mission includes the words "a caring community ---- pursuing justice". Easy words but they call us to action. Now is the time to actually do something.

For over a year, UUCOV has been meeting with the Laurel Civic Association (LCA) for the purpose of developing a program by which UUCOV could support our neighbors. Our neighbors in the Laurel area of town are economically challenged and have been systematically denied access to resources that we take for granted. Many UUCOV members have volunteered at the Association with their after-school program or helped sort food at their food drive. So, we know LCA.

We have a proposal that our friends at LCA are asking our help with.

LCA along with the Manatee Credit Union want to bring banking services to our neighbors who are "unbanked, underbanked and underserved". They want to provide access to banking services that you and I take for granted – bank loans, credit cards, checking accounts and even check cashing services. Michael Fluker, Executive Director of LCA, and his board calls this EMPOWERMENT. And our help is being asked for.

The Federal Treasury Department has identified this issue, lack of banking services in areas across this country and have certified banking entities as Community Development Financial



Institutions (CDFIs). CDFI's have in their charter the mandate to serve underserved areas. The Manatee Credit Union is one such entity. And CDFI's and their work are supported by UUA. The City of Sarasota has entered into an agreement with Manatee Credit Union to serve an underserved part of Sarasota.

LCA is hoping to raise \$20,000 in the several months or so to initiate a banking program with the Manatee Credit Union that will include the services

mentioned, but also an education program to assist families to learn banking skills. This \$20,000 will underwrite the beginning of this program and will serve as seed money to allow LCA to pilot this program and, hopefully, grow it.

Your Board of Trustees has followed this program development over the past year and supports it. We have currently an initial \$5,000 matching donation. So, the first \$5,000 of donations from the congregation will be matched dollar for dollar. It is our goal to raise \$20,000. This \$20,000 will underwrite \$200,000 borrowing power.

We have educated ourselves on our privilege, we have read about the plight of our citizens of color, we have attended lectures, we have heard personal stories. We have learned not to make decisions for others. We have learned of the systemic injustices in our society. This is an opportunity to actually do something.

No donation will be too small. Checks should be made out to UUCOV with 'LCA' in the memo line.

We expect to be able to say our congregation started a program that made a significant difference in people's lives and we responded with a yes, when asked to help.



Religious Educator Position Vacancy

The Unitarian Universalist Congregation of Venice located in Venice, Florida is looking to fill the position for a halftime (20 hours/week) Religious Educator.

We are a congregation of 230 members with a small youth religious education program along with a medium sized adult program. We

currently have 10-15 youth and about 50 adults participating in our various programs depending on the seasonal membership and attendance. The goal is to envision, evaluate, and implement a diverse, robust, and fun lifespan religious program for all ages. This program will provide an understanding of Unitarian Universalism and inspire congregants to develop their own religious

identity or spirituality.

The primary duties are:

- 1. To provide overall vision and work collaboratively with RE committees in developing, programming and using curricula.
- 2. To develop a yearly calendar in collaboration with the Minister and the RE committees.
- 3. To lead recruitment, annual training and development of capable volunteers to teach and/or facilitate RE programs.
- 4. To oversee the administration of the lifespan religious education program, including registration, safe congregation policies, procedures, and maintenance of database and finances.
- 5. To evaluate and implement age appropriate curricula across the lifespan, reflecting a wide variety of spiritual and social justice interests.
- 6. To administer and participate in a comprehensive and forward-thinking lifespan religious program that promotes the principles of Unitarian Universalism and draws upon curricula and materials provided by the UUA and others.
- 7. To plan occasional "intergenerational" Sunday services with feature involvement by the children in collaboration with the Minister.

The Religious Educator will report to the Minister and work closely with the RE committees (Youth RE Committee and Adult RE Committee). The Religious Educator will collaborate with other committees and the Coordinating Council to maximize service to the community.

The Religious Educator should be familiar with UUA curricula, should have experience with multi age youth and adults, should have good communication and organizational skills. S/he should have experience with Microsoft Office and social media connectivity. College experience is preferred. The candidate must be able to pass a background check. Please submit three references. Compensation will be determined based on experience and qualifications.

- Direct experience of that transcending mystery and wonder, affirmed in all cultures, which moves us to a renewal of spirit and an openness to the forces that create and uphold life;
- Words and deeds of prophetic women and men which challenge us to confront powers and structures of evil with justice, compassion, and the transforming power of love;
- Wisdom from the world's religions which inspires us in our ethical and spiritual life;
- Jewish and Christian teachings which call us to respond to God's love by loving our neighbors as ourselves;
- Humanist teachings which counsel us to heed the guidance of reason and the results of science, and warn us against idolatries of the mind and spirit.
- Spiritual teachings of Earth-centered traditions which celebrate the sacred circle of life and instruct us to live in harmony with the rhythms of nature.

Grateful for the religious pluralism which enriches and ennobles our faith, we are inspired to deepen our understanding and expand our vision. As free congregations we enter into this covenant, promising to one another our mutual trust and support.
